1. IN CONSIDERATION of the sum of One Dollar (\$ 1.00) and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Spider Lake Springs Campers Association (the 'Licensor') hereby grants to:

(hereinafter referred to as the "tenants", and in the Rules and Regulations as a "License Holder")

a TEMPORARY PERMIT TO OCCUPY a certain portion of those Lands owned by Spider Lake Springs Holdings Inc. (the 'Company') and more particularly described as: Lot 1, block 360, Newcastle and Alberni District and Block 390 Newcastle District, Plan VIP 60844 (hereinafter referred to as the Resort Area of the "lands") which said Lands have been leased to Spider Lake Springs Campers Association by the Company for the purpose of operating and maintaining a Resort facility known as Spider Lake Springs Resort.

2. The License Area shall be that portion of the Lands delineated by the Licensor and denominated Campsite No. _____ (hereinafter referred to as the "License Area")
3. The 'tenants' right to occupy the License Area shall be exclusive for the duration of the Temporary Permit. The 'tenants' may also have access to and the use of any areas designated by the Licensor as common use facilities, subject to the control and regulation of the Association.
4. This Temporary Permit to Occupy shall remain in force and effect for the period indicated on the 'SLSCA TENANTS AGREEMENT' (copy of which shall be attached to and form part of this Permit).

SUSPENSION AND REVOCATION OF THE PERMIT

5. The *'tenants'* right to access the Resort, to use the common facilities and to occupy the License Area may be suspended:
 - a.) For non-payment of the payments to the License Holder or non-payment of the Administration Fee to SLSCA.
 - b.) For breach of the Rules and Regulations determined and set by the Association.

RESTRICTION ON ASSIGNMENT OR SUBLETTING

6. This Permit is for the use of the *'tenants'* his family and guests (all as registered on the accompanying Supplemental License to Occupy sheet). This Permit may not be assigned or sublet to any other individual or corporation.

OBSERVANCE OF BY-LAWS, RULES AND REGULATIONS

7. This Temporary Permit to Occupy notwithstanding, the *'tenants'* his family and guests shall:
 - a.) Observe the Rules and Regulations concerning use of the License Area and the Common facilities in the Resort set from time to time by the Association;
 - b.) Comply with all zoning and land use by-laws set by the Regional District of Nanaimo from time to time;
 - c.) Comply with all Provincial Land use regulations, health regulations and any other Regulations set or in force by Her Majesty the Queen in right of the Province of British Columbia.

WAIVER OF LIABILITY AND INDEMNITY

8. The *'tenants'*, on his/her own behalf and on behalf of his family and guests hereby accepts full responsibility for any injury, loss or damage including injury to any person whatsoever, and damage to any property owned by the Licensee, his family or guests, property of the License Holder, and property of any third party which is caused by or arises out of or in connection with the *'tenants'* occupation or use of the License Area and/or any other resort facility, whether caused by the *'tenants'*, any member of his family, his guest, or by third party and whether by accident or the result of negligence on the part of any person whatsoever, and the *'tenants'*, in consideration of the granting of this Permit, shall waive his right to make any claim(s) against and shall agree to indemnify and hold harmless Spider Lake Springs Holdings Inc., Spider Lake Springs Campers Assoc., all Directors and Officers of the Company and the Association, and all employees of the Company and the Association, of and from any claim, loss or damage caused by or arising out of or in conjunction with the use of the Resort Facility, the common facilities in the Resort Area, the recreational facilities and the License Area by the *'tenants'*, any member of his family and his guests inclusive of any accident, claim, loss or damage which may arise out of or result from the negligence of any individual whatsoever inclusive of person or persons in the employ of the Company or the Association.
