Occupancy: 4.07 Any visiting Recreational Vehicle that is owned by a License Holder's Guest and intends to remain in the Resort **must** be registered. Guest Units may stay for a period not to exceed seven (7) days consecutive and a cumulative period of twenty-one (21) days in any calendar year.

Did You Know?:

Over the July long weekend there were 170 sites occupied and 15 guest units. The water in the ponds comes from underground springs. Evelyn's pond extension is also fed from a creek that runs through the farmer's property. The creeks leaving these ponds flows into Larry's and Ryan's ponds.

Waterslide: Waterslide hours are 1:30pm to 3:30pm.

Parking Permits: The Board is amending when the permits should be visible in vehicles. Owner and guest permits do not have to be used when driving in and out of the park. Parking Permits must be visible when parked anywhere in the resort, including when parked in campsites. Permits can be picked up from Fern at the second security site near the front gate, Tuesdays 1-3pm & Saturdays 9-11am.

RV Black Water Tanks: When you finish draining the tank, don't forget to close the valve. If left open the sewer gases escape out of the vents through the roof of the RV and stink up the whole neighborhood.

Dog Park: Owners must stop letting their dogs dig holes in this area. This is one of our septic fields and if we were inspected and holes were found the park would be shut down.

Refundable Containers: Please do not put waste products or soup cans in with your refundable containers at the bottle sorting shed.

Uninterrupted Enjoyment: No person shall use or operate any motorized or power equipment before the hour of 9:00am or after the hour of 5:00pm daily. No person shall engage in noisy construction projects involving the use of hand tools or power tools before the hour of 9:00am or after the hour of 5:00pm daily.

Vandalism: If vandalism of the washrooms continues, we will be forced to close them each evening. As a result of ongoing vandalism there are now cameras at the longhouse.

Security Gate: When entering or exiting the security gate you must ensure that it is closed before proceeding.
