Important Notes Regarding Tree Removal:

- Trees **MUST** be identifiable based only on the information provided on this form, flagging tape is recommended and available from any maintenance staff member. Trees that can not be definitively identified will be skipped.
 - SLSCA will cover the costs to remove dangerous trees.
 - A portion of the tree *may* be left as firewood for the shareholder, at the discretion of management.
 - All costs for the removal of non-danger trees are the responsibility of the shareholder, except in cases where portions of the tree can be milled for lumber.
 - Logs are the property of Spider Lake Springs and any shareholders found cutting up such logs will be billed the entire cost of tree removal and clean-up.
 - Where a shareholder has paid the entire cost of removal, all logs will be left as firewood.
 - SLSCA staff and management do not determine the 'Danger' status of trees except in obvious cases, IE: major lean, cracked, rotten, dead etc.
 - SLSCA hires an Arborist to determine the status of all *suspected* danger trees.
 - Management does not guarantee any timelines or dates for removal of trees by an SLSCA hired Arborist.
 - Removal of trees for 'aesthetic purposes' includes any reason other than potential for danger, including, but not limited to: increasing sun exposure, site re-configuring, issues with tree litter (leaves, needles, bugs, twigs, seeds, etc).
 - Shareholders are permitted to have a maximum of 3 trees removed per year.
 - When utilizing the services of your own Arborist, the office must receive proof of insurance and WorkSafe status prior to any work starting. Additionally, mandatory written permission from the SLSCA office is required.
 - Your signature below is **required** to complete this form, and indicates an understanding of the above conditions and limitations. Failure to sign may result in your trees being skipped or missed altogether.
 - “Quote Only” means the SLSCA hired Arborist will prepare a quote for the aesthetic removal of a tree, but no work will be done until the quote is approved by the shareholder.
 - “Remove & Invoice” means the SLSCA hired Arborist will remove the tree and provide a separate invoice for payment by the shareholder.
