Septic: Lysol wipes and baby wipes **ABSOLUTELY** can not be flushed down the toilets. Staff spent 3 days digging up one very small area of the park. This came to a final cost of almost \$3000.

Water Consumption on Long Weekends: Power washing restrictions during long weekends are Thursday from 5pm to Tuesday morning 9am.

Site Cleanup: All tarps, temporary covers, and covers of any kind placed over the roofs of Recreational Vehicle's, Sleeping Units, or other structures, shall be totally removed and neatly stored in/on the designated campsite by the last day on the May long weekend.

Every Shareholder (owner) shall complete a general cleanup of his/her designated campsite prior to June 1st of every camping season.

Guest RV's, Section 4.07: Guest Units must be registered. RV's may stay for a period not to exceed seven (7) days consecutive and a cumulative period of twenty-one (21) days in any calendar year. Power Bars: The use of power bars for appliances is suggested instead of plugging appliances directly into outlets. This way the power bar will trip not the trailer breakers.

Dogs: Campers are responsible to clean up after them. All dogs must be kept on a leash when outside of a campsite and secured within a campsite. There are 2 dog parks, where your pet can be off leash but must be supervised by the owner.
